The undersigned shall not assert any right arising from payment or other performance hereunder until all sums owing SELLER have been paid. The undersigned also guarantee(s) to SELLER the payment of any and all expenses paid or incurred by it (including reasonable attorney's fees) in connection with the collection of all sums and the enforcement of all obligations guaranteed hereunder whether such collection or enforcement be from the CUSTOMER or from one or more of the undersigned.
